EXAMINATION-2020**

**1. IMPORTANT INSTRUCTIONS TO CANDIDATES**

i	BSF will hold open competitive Examination for recruitment of male candidates to the different posts of Group 'B' & 'C' (Non Gazetted) of Water Wing in year 2020.
ii	Candidates are advised to go through the requirement of educational/technical qualification, age, physical standards, physical efficiency test etc. and satisfy themselves that they are eligible for the posts, before applying. BSF reserves the right to cancel the candidature of any candidate at any stage of the selection process, if he is found not qualifying any of the prescribed eligibility criteria.
iii	Candidates seeking reservation benefits for Govt. Servant/EWS/OBC/SC/ST/Ex-Servicemen must ensure that they are entitled to such reservation as per eligibility prescribed in the notice. They should also be in possession of the certificates in the format prescribed by Government of India in support of their claim at the time of application.
iv	Central Government Employees/Servants claiming age relaxation should be in possession of a certificate in the prescribed format from their office, in respect of the length of continuous service which should be for not less than three years in the immediate period preceding the closing date for receipt of application. They should continue to have the status of Central Government Civilian Servants/Employees from the day of application till the time of appointment on the basis of their performance in this examination to be eligible for such age relaxation.
v	<b>Examination Fee :</b> Each application should be accompanied by a Demand Draft/ Postal Order of ₹ 200/- for the post of SI (Master), SI (Workshop) & SI (Engine Driver) and ₹ 100/- for the post of HC (Master), HC (Workshop), HC (Engine Driver) & CT (Crew) as examination fee in favour of the addressee where the Application Form is being submitted by the candidate. However, fee is exempted for candidates belonging to Scheduled Caste, Scheduled Tribe, BSF Candidates, Ex-Servicemen. <b><i>Fee once paid will not be refunded under any circumstance.</i></b>
vi	<b>Closing Date:</b> Application duly filled up in the given format may be sent to concerned Examination Centre, on or before <b>16<sup>th</sup> March'2020</b> . The last date of receipt of application in respect of candidates belonging to far flung areas i.e. North Eastern States, Sikkim, Ladakh, Lahaul & Spiti Districts and Pangi Sub Division of Chamba District of Himachal Pradesh, the Union Territory of Andaman and Nicobar Islands or the Union territory of Lakshadweep is <b>30<sup>th</sup> March'2020</b> i.e. 45 days from the date of publication of notice in Employment News.
vii	Application Form (Annexure-'A') and Admit Cards (Annexure-'A-1' & 'A-2') must be filled by the candidates in his own handwriting. Correction/cutting to be avoided. However, correction, if any, should be legible and attested by the candidate.



viii	Applications, which are not on prescribed format or not accompanied by the required enclosures or incomplete or defective shall be summarily rejected. No representation or correspondence regarding such rejection shall be entertained under any circumstances.
ix	The envelope containing the application must be superscribed in bold letters as <b>“APPLICATION FOR THE POST OF SI(MASTER), SI(ENGINE DRIVER), SI(WORKSHOP), HC(MASTER), HC(ENGINE DRIVER), HC(WORKSHOP) &amp; CT(CREW) IN BSF WATER WING EXAMINATION-2020”</b>
x	Candidate serving in Government/Public Sector Undertakings should apply through proper channel. No objection certificate from their employer will be required to be submitted with Application Form.
xi	Candidates are not required to submit any original certificate in support to their claims. They should ensure they fulfill all the eligibility conditions for admission to the tests. <b>If on verification at a later stage it is found that they do not fulfill any of the eligibility conditions, their candidature will be cancelled by the Selection Board.</b>
xii	All eligible candidates who apply in response to this advertisement before the closing date will be assigned Registration/Roll Numbers, if they fulfill the terms and conditions as given in this advertisement and found eligible for applied posts. Only such eligible candidates will be communicated through Call letters/Admit Cards for appearing in the first phase of selection process i.e. Written Examination. However, any candidate found not eligible at later stage in any aspect, his candidature will be cancelled.
xiii	An employee serving in the same rank and pay grade will not be entitled to apply for said post.
xiv	Candidates belonging to the Physically Handicapped category are <b>not eligible</b> to apply for this examination.
xv	The recruitment will be done on All India Basis.
xvi	Candidates are informed that the Written Examination will be followed by Documentation, Physical Standard Test, Physical Efficiency Test, Trade Test & Medical Examination. Final merit list as per the advertised vacancies will be prepared in respect of candidates who have qualified all the stages/events. Failure at any stage/event will lead to disqualification and candidate will not be allowed to appear in next stage event.
xvii	The recruitment board shall not be liable for any claim arising out of any injury etc. suffered during the tests. The decision of the recruitment board shall be final in all matters connected with this recruitment.
xviii	The appointment will be subject to the conditions that the candidates are medically as well as physically fit. The selected candidates will have to undergo Basic Training at any of the Training Institutions of BSF. The services of those candidates who fail to complete the training successfully are liable to be terminated.
xix	Correspondence will only be made on the present address of the candidate in his Application Form. BSF will not be responsible for any postal delay or wrong delivery.
xx	Mobile, Calculator and other Electronic Gadgets are banned within the premises of the Examination Centers.
xxi	The selected candidate are liable to be posted anywhere in the Country as per the transfer policy of the Force. These posts are for BSF Water Wing and selected individual will be required to operate and maintain/repair different type of boats/water crafts in riverine international border of India.
xxii	Selected candidate will be governed by BSF Act and Rules.
xxiii	On appointment they shall be entitled for pension benefits as per the <b>“New Restructured Defined Contributory Pension Scheme”</b> applicable for the new entrants to the Central Government services w.e.f 01 <sup>st</sup> Jan’ 2004.



**NOTE-I:** Final scrutiny of eligibility as per criteria with regards to age, educational qualification, caste, physical standard will be undertaken at the time of final selection/medical examination. Therefore, candidature will be accepted only provisionally till final selection. At the time of final selection when scrutiny is undertaken and if any claim made in application is not found substantiated then the candidature will be cancelled and the decision of BSF in this regard shall be final.

2. Applications are invited from male Indian citizens to fill up the following vacancies for the various posts of group 'B' & 'C' (Combatised) Water Wing in the Border Security Force, Ministry of Home Affairs, Government of India. The posts are temporary but likely to become permanent.

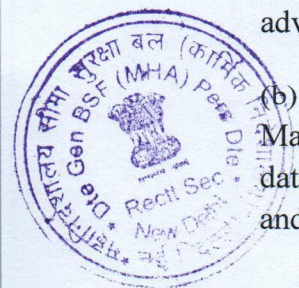

### 3. AGE DETERMINATION AND RELAXATION

(a) The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates in India which will be 30 days from the date of publication of this advertisement in the 'Employment News'.

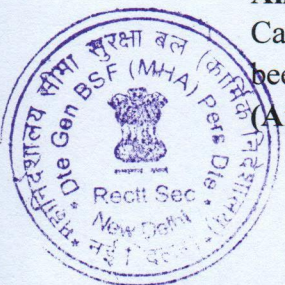
(b) Candidates should note that only the Date of Birth as recorded in the Matriculation/Secondary Examination Certificate or an equivalent certificate available on the date of submission of application will be accepted by the BSF for determining the age eligibility and no subsequent request for its change will be considered or granted.



(c) Age relaxation available to different category of eligible candidates, for claiming Age Relaxation as on the date of reckoning:

(d) Candidates who wish to be considered against vacancies reserved/or seek age-relaxation must submit requisite certificate from the Competent Authority, in the prescribed format, when such certificates are sought by the selection board at the time of documentation. Otherwise, their claim for SC/ST/OBC status will not be entertained and their candidature/applications will be considered under General (UR) category. The formats of the certificates are annexed as **Annexure –‘B’, ‘B-1’ and ‘C’**. Certificates obtained in any other format will not be accepted. Candidates claiming OBC status may note that certificate on **Creamy Layer Status** should have been obtained within three years before the closing date in the prescribed format only (**Annexure-‘B-1’**).



**Note:-I** Candidates are warned that they will be permanently debarred from the examination conducted by the BSF in case they fraudulently claim SC, ST, OBC & Ex-Serviceman Status.

**Note:-II** Candidate should note that the date of birth as recorded in the Matriculation/Secondary Examination Certificate or an equivalent certificate available on the closing date of submission of application will be accepted for determining the age and no subsequent request for its change will be considered or granted.

4. **DEFINITIONS/CONDITIONS FOR EX-SERVICEMEN**

**An 'Ex-Servicemen' means a person :-**

a) Who has serviced in any rank whether as a combatant or non-combatant in the Regular Army, Navy, Air Force of the Indian Union, and

- i) Who either has been retired or relieved or discharged from such service whether at his own request or being relieved by the employer after earning his or her pension; or
- ii) Who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension; or
- iii) Who has been released from such service as a result of reduction in establishment;

**or**

b) Who has released from such service after completing the specific period of engagement, otherwise than at his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity; and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service;

**or**

(c) Personnel of the Army Postal Service who are part of Regular Army and retired from the Army Postal Service without reversion to their parent service with pension, or are released from the Army Postal service on medical grounds attributable to or aggravated by military service or circumstance beyond their control and awarded medical or other disability pension;

**or**

d) Personnel who were on deputation in Army Postal service for more than six months prior to the 14<sup>th</sup> April, 1987;

**or**

e) Gallantry award winners of the Armed forces including personnel of Territorial Army;

**or**

f) Ex-recruits boarded out or relieved on medical ground and granted medical disability pension.

**Note-I :** Character certificate : Minimum requirement will be 'Good' category certificate.

**Note-II :** All Ex-Servicemen are not required to undergo Physical Efficiency Test (PET). Ex-Servicemen are required to fulfill the Physical Standard Test (PST) prescribed for the concerned posts. However, all Ex-Servicemen are required to pass the Written Examination, Documentation, Trade Test and Medical Examination.



**Note-III:** The SC, ST & OBC candidates selected against the vacancies reserved for ex-servicemen shall be adjusted against vacancies reserved for SC, ST and OBC respectively. In case reserved vacancy for Ex-Servicemen remained unfilled due to non availability of eligible or qualified candidates, the same shall be filled by candidates from non-ex-servicemen category.

5. **DEFINITION/CONDITIONS FOR ECONOMICALLY WEAKER SECTIONS(EWSs)**

According to the Department of Personnel & Training (DoP&T) Office Memorandum No. 36039/1/2019-Estt (Res) dated 31/01/2019. **“The person belonging to EWSs who are not covered under the scheme of reservation for SCs, STs and OBCs shall get 10% reservation in direct recruitment in civil posts and services in the Government of India.”**

(a) Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs. 8.00 lakh (Rupees Eight Lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

(b) Also persons whose family owns or possess any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-

- (i) 5 acres of agricultural land and above;
- (ii) Residential flat of 1000 sq. ft. and above;
- (iii) Residential plot of 100 sq. yards and above in notified municipalities;
- (iv) Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

(c) The property held by a “Family” in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

(d) The term “Family” for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

Owing to introduction of 10% reservation to Economically Weaker Sections (EWSs) from UR category w.e.f. 01.02.2019, vacancies reserved for EWS category will be filled up by the candidates who produces requisite valid INCOME & ASSET CERTIFICATE” issued by the Competent Authority as per the specimen attached at **Annexure –‘E’**. However, there would be NO repeat No any relaxation in any of the standards for EWS category candidates, except reservation of 10% vacancies.

Candidates availing the 10% reservation allocated for Economically Weaker Section (EWS), should submit a valid “INCOME & ASSET CERTIFICATE” as per the specimen attached at Annexure –‘E’.

**Note :** The crucial date for submitting Income and Asset certificate by the candidate will be the closing date for receipt of application for the post.

**Note:-I :** Relaxation in height and chest (as the case may be) as mentioned above will be permissible only on production of certificate in the prescribed proforma issued by the District authorities where they ordinarily reside(s) (Annexure- 'D').

7. **SELECTION PROCEDURE**

The selection procedure will be held in two phases which are as under:-

**(a) Phase-I**

- (i) Written Examination

**(b) Phase-II**

- (i) Documentation  
(ii) Physical Measurement  
(iii) Physical Efficiency Test  
(iv) Trade Test  
(v) Medical Examination.

**(a) First Phase**

**(i) Written Examination**

The written examination will be conducted at the selected centres on the date and time fixed by HQ DG BSF, which will be communicated to all candidates through call letters by respective RAs as well as through BSF website. Admission in Written Examination Hall will be purely on production of Call Letter/Admit Card dispatched to the eligible candidates from respective RAs. Question papers will be printed in bilingual i.e. in Hindi & English both. There will be one composite paper of objective type with multiple choices to be answered on an OMR Answer Sheet. The written examination question paper will be consisting of following subjects :-

**QUALIFYING MARKS FOR WRITTEN EXAMINATION**

The qualifying marks of Candidates for Written Examination are as follows:-

- (a) Candidates of Gen/OBC/EWS = 35%
- (b) Candidates of SC/ST = 33%

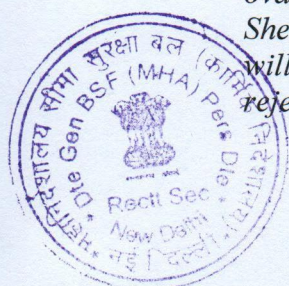
*However, number of written qualified candidates to be called for 2<sup>nd</sup> Phase Examination i.e Documentation, PST/PET, Trade test and Medical Examination may be restricted to the five (05) times the number of vacancies advertised or number of candidates qualified in Written Examination whichever is lesser. There will be no re-evaluation of OMR Answer Sheets.*

**Note:-I** Relaxation of respective category will only be given to those cases where vacancies are available in the respective category for the applied post/trade. If vacancies of the respective category are not available in the post/trade and candidate is not taking relaxation of his category, he will be treated as “Unreserved Category” candidate. If the vacancies of reserved category are not available in the respective category of the post/trade and reserved category candidate does not fulfill the criteria of Unreserved Category candidate, candidature of those candidates will be rejected at any stage.

**Note:-II** Candidates are not permitted to use Mobile Phone, Calculator or any other electronic/electrical device for answering any paper (Test Booklets). Candidates must not, therefore, bring Mobile Phone, Calculator or any other electronic/electrical device inside the Examination premises. Possession of these items, whether in use or not, will be considered as “use of unfair means” in the Examination and appropriate action will be taken by the department against such candidates, as per extant policy of the department.

**Note:-III** Discrepancies in Question Paper, if any, may be brought to the notice of the selection board in writing immediately on completion of holding the examination. Representation submitted subsequently will not be considered.

**Note-IV** The Written Examination will be conducted on OMR based answer sheet. If the candidate did not shade/wrongly shaded/did not fill/wrongly filled his mandatory data ovals i.e. Roll number, question booklet series code and category etc in the OMR Answer Sheet, the OMR Answer Sheet will be rejected at the initial stage and the OMR Answer Sheet will not be further evaluated for which candidates himself will be responsible for such rejection.



(b) **Second Phase**

Those candidates declared pass in the Written Examination (First phase) will appear in the second phase at the following centers.

Stages of Second Phase Examination will be as follows:-

(i) **Documentation**

Candidates will have to produce original copies of all the documents to testify their eligibility for the post on account of Age, Education, Technical Qualification, Experience, caste, relaxation for PST etc.

(ii) **Physical Standard Test (PST)**

Physical measurement will be carried out by the selection Board to assess the height, weight and chest of candidates according to the prescribed physical standard as mentioned in Para above.

(iii) **Physical Efficiency Test (PET)**

Candidates are required to qualify following events:-

- (a) 1 Mile Race - 08 Minutes
- (b) High Jump - 3 Feet 06 Inches (03 attempts)
- (c) Long Jump - 11 Feet (03 attempts)

**Note:-I** All Ex-Servicemen are not required to undergo Physical Efficiency Test (PET). Ex-Servicemen are required to fulfill the Physical Standard Test (PST) prescribed for the concerned posts. However, all Ex-Servicemen are required to pass the Written Examination, Documentation, Trade Test and Medical Examination.

**Note:-II** Use of performance enhancing drugs in PET, be treated as disqualification.

(iv) **Trade Test**

Trade Test for each post will be carried out by the selection Board to assess the knowledge and experience of candidate in the respective technical field or trade applied by the candidate. Swimming Test for the post of CT (Crew) will also be carried out by the Selection Board.



(v) **Medical Examination**

Candidates who qualify all the above stages i.e. Written Examination, Documentation, PST/PET & Trade Test will undergo detailed Medical Examination, which will be carried out by detailed Medical Officer to assess their medical fitness. If found Unfit in the Medical Examination, they may prefer an appeal for Review Medical Examination within the prescribed time limit of 15 days. The provision for appeal for Review Medical Examination is only against an **error of judgment** of the Medical Examination Board. On acceptance of the appeal Review Medical Examination will be conducted and the decision of Review Medical Board will be final and no appeal/representation against the decision of the Review Medical Board will be entertained. The Medical Standards will be followed as provided in Guidelines for Recruitment Medical Examination in CAPFs & AR issued by Pers-II, Police-II Division, MHA (GOI) on 20<sup>th</sup> May 2015.

(a) **Eye Sight**
