The Himachal Pradesh National Law University, Shimla was established by the Himachal Pradesh National Law University Act, 2016 (16 of 2016) in September, 2016. The University started functioning from 5th October, 2016. The first batch of B.A. LL.B. (Hons.) (Five Year Integrated Course) was inducted in October, 2016. The batches of B.A./B.B.A.LL.B., LL.M. (One Year Programme), and Ph.D. were inducted in the Academic Sessions 2017-18, and 2018-19 through Himachal Pradesh National Law Entrance Test (HPNLET). The University is currently operating from Himachal Pradesh Judicial Academy Campus.

HPNLU Library, within a short period of time, has taken great leaps to become a leading center for the dissemination of knowledge. 

HOSTELS

The Himachal Pradesh National Law University, Shimla has separate Boys and Girls Hostels (operated through hired buildings). There is a central mess facility for all the hostels. Hostel rooms are furnished with bed, study table, chair, mattress and almirah. Proper sanitation, hygiene is maintained and *wi-fi* facility is available. Transportation is provided for the residents of the Hostels. For safety and security of hostel inmates, each hostel has security guards.

HEALTH CARE

University has ambulance facility in the campus. Medical care is provided through Government Hospital, Dhami, which is within 3 km from the University Campus.

COURSES

The HPNLU offers following Courses:

- B.A.LL.B. (Hons.) Five-Year Integrated Course
- B.B.A.LL.B. (Hons.) Five-Year Integrated Course
- LL.M. (One-Year Programme)
- Ph.D. (Law)

Eligibility for Admission:

The Admission is exclusively based on the merit in the Common Law Admission Test (CLAT). However, to qualify for admission:

- Candidates should have passed 12th (10+2) examination from any recognized board with minimum 50 % (45 % for S.C/S.T.) in one attempt Students who have appeared for 10+2 finals exams and awaiting results are also eligible to apply, subject to submission of passing certificate by announced date.
- Applicants who have passed 10+2 through Open Universities system directly without having any basic qualification are not eligible.

INTAKE AND RESERVATION FOR B.A./B.B.A. LL. B. (Hons-. 2018-19)

In each Under Graduate Programmes *i. e.* B.A./B.B.A. LL. B. (Hons.) 60 students is admitted.

Out of the total sanctioned strength of each course, 25 % seats are reserved for Himachal Pradesh State Domicile Candidates *as per* HPNLU Act. 2016.

International Students, including NRI:

The Himachal Pradesh National Law University Act, 2016 and Himachal Pradesh National Law University, Shimla Courses of Study, Admission, Curriculum, and Examination Regulations 2016 provides a total of 15% supernumerary seats i.e., in addition to the total intake.

Admission to the category of 'International Students' and 'NRI' shall be direct admission on the basis of inter-se merit of the qualifying examination after due verification of equivalent and eligibility conditions. All International Students and 'NRI' candidates must apply directly to the Registrar, HPNLU Shimla on prescribed admission form (available at HPNLU website) along with the demand draft of 3000/- in favour of the Registrar, HPNLU, payable at Shimla.

The candidates shall also enclose supporting documents regarding qualifications, proof of age, NRI status (in case of NRI category) and a copy of the passport (in case of International Student).

For International Students, NRIs, Kashmiri Migrants and Residents of J&K, the last date for application in UG and PG Courses is 1st July 2019.
