India is on the threshold of a Development Revolution. Higher education including legal education will determine the quality and direction of the Development Process. With millions of talented youth with higher education entering the job market, nothing can stop the Nation from achieving its development goals sooner than later. As a country committed to rule of law, democracy and human rights, it is the function of legal institutions to organize development in such a manner that the Constitution prescribes. In this process, legal personnel have a significant role to play outside the conventional role of dispute settlement.

Law study, therefore, is not merely a private good but also a public good in which the society has special interest to sustain. There is no other subject so close to life in all its aspects as the subject of law. For the same reason, study of law is a life-long process for which university education is just the beginning.

It is common experience of many of us in the teaching profession that when students join the law school, they are determined to work for justice to weaker sections and wanting to change systems that perpetuate inequality and exploitation in society. It is also our experience that once they complete studies and leave the law school, they tend to lose their idealism and join forces which maintain the same old social order. Of course, there is lot of money one can make in a legal career and there is nothing wrong in advocating the cause of the rich who can pay enough money for legal services.

But if such action results in non-availability or non-affordability of quality legal services to the poor and the marginalized, there is serious risk of the profession getting alienated from the people and justice getting derailed in the process. This is suicidal for the profession as well as for the country and its constitutional values.

A recent report submitted by the Law Commission has recommended several changes to the Advocates Act towards restructuring the organization and management of the legal profession in India with a view to maintain the nobility and public interest goals of the profession. Furthermore, the profession is today diversified into litigation bar, corporate and in-house lawyers, mediators, arbitrators and trans-national legal practitioners. In emerging areas of legal practice, lawyers are compelled to partner with professionals outside law to provide appropriate services to the clients. With trade in legal services becoming a reality under the WTO, lawyers have to prepare themselves for trans-national legal practice as well which will change the character of the profession as we see it today. In short, those who are entering the practice of law in future may have to adopt new ways of thinking in respect of delivery of services and management of profession.

Study of law prepares one not only to become a legal practitioner. It enables one to take a variety of career options including judiciary, journalism, civil service, politics, teaching and social work. In all these careers, what makes law study relevant is its relation to 'JUSTICE', the eternal quest of every human being. You are welcome to study law and be a justice worker for maximizing justice and fairness in society.

In Lloyd College of Law, you will find plenty of opportunities not just to earn a law degree, but to learn many things about law from outside the classroom and the library. Learning law through experience gives you insights on how law functions in society. Look out for occasions for experiential learning even if you have to forego your vacations to avail of such experiences. Improve your communication skills and your knowledge of contemporary events. A great career full of intellectual challenges awaits you. Remember the adage that "Law is a jealous mistress" and there is no room in it for the lazy and the mediocre.

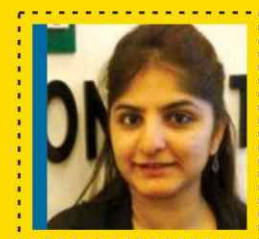

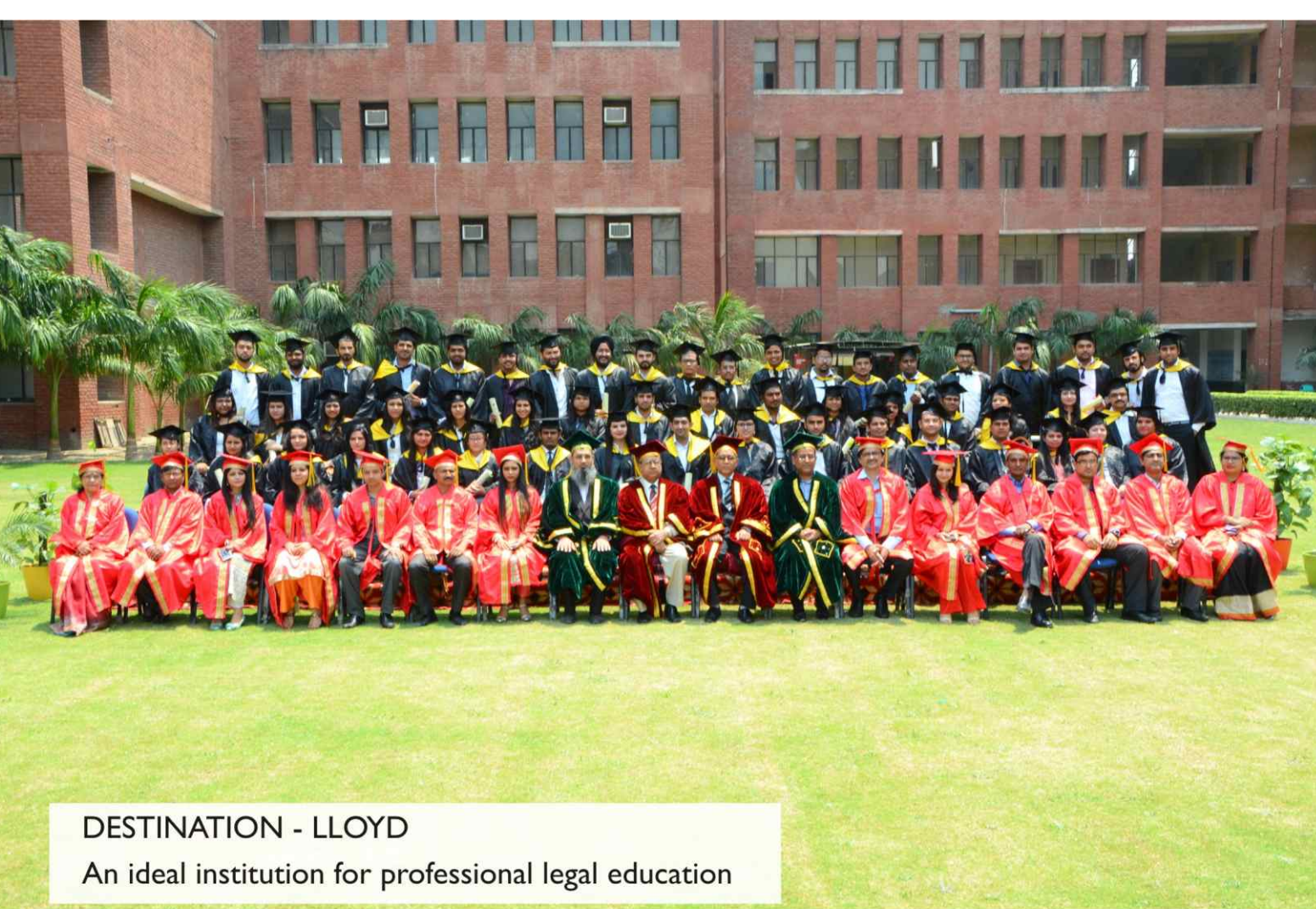

Education and employment of human resources is the most frequent and least frictional process of human development, social transformation and civilizational movement. Law and justice are two sides of the same coin in the modern legal systems. Legal education is essentially a justice education. Justice in Indian legal system is preambled as social, economic and political perspectives. Equality of status and opportunity in education and employment is a fundamental right as constitutionalized. Legal education being justice education in an adversarial system has become a skill education. Legal service being professional service requires lot of skill sets for the appropriate and better delivery of professional services. Moreover, in an uncertain job market, skills are the best security. As a law student one must have to gain many practical, personal, interpersonal, and professional skills through out his degree.

Employability

Employability skills are those that make the link from learning to earning. Enhancing Student Employability Co-ordination includes these two aspects and is more in line with our view of employability skills, a set of achievements—skills, understandings and personal attributes—that makes graduates more likely to gain employment and be successful in their chosen occupations, which benefits themselves, the workforce, the community and the economy. Therefore, employability skills can be considered to be a range of skills and capabilities that virtually every employer is looking for in potential graduate recruits and an essential precondition for the effective development and use of other, more specialist or technical skills required for particular jobs. They are also a key underpin to your effectiveness at work. Exploring these themes of development and demonstration of skills is the primary purpose of studentship at Lloyd. These transferable skills can be categorized under a number of broader headings:

Personal skills: such as self-management, professional, and ethical behavior and organizational skills

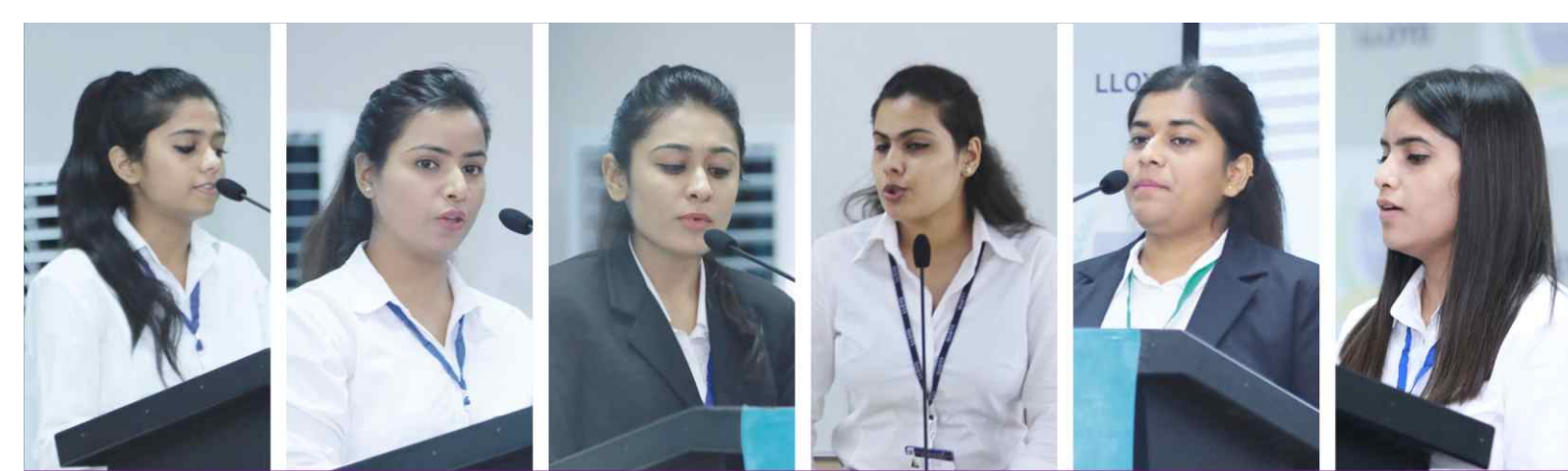
Interpersonal skills: Such as team working, written and verbal communication, customer service, and networking.

Public Interest Lawyering Cell

A PIL Center is established wherein 12 students are selected through an interview process and are being assigned issues of public importance. They are involved in drafting of petitions guided by the faculty in charge Mr. Vinayak Tripathi and Mr. Faizal Ahmed Khan. The processes of filing of the petitions in the court of law are being assisted and supervised by Mr. Sarvarajan – Advocate on Record and Mr. Sanjay Vashishtha – Adv. Supreme Court of India. The P.I.L. cell has successfully filed and relieved in the two PIL's and preparing to file two more Social interest litigations.

SHABNAM AND ORS. vs. SWACHH BHARAT MISSION (URBAN) AND ORS. - W.P (C) 7911/2018 - HON'BLE HIGH COURT OF DELHI: This Writ Petition was filed by **Ms. Shabnam Khan, Ms. Sonali Chauhan and Mr. Nitesh Singh** all LL.B. – Sem. IV students of Lloyd Law College seeking remedy for people dwelling in a slum area of Gyaspur, Sarai Kale Khan who were deprived of basic amenities. It was prayed before the Hon'ble High Court that Anganwadi and public convenience be provided to the people of the above concerned area and fortunately the Hon'ble High Court issued order in our favor and provided for Anganwadi and the case is pending in which we are reiterating for the public convenience.

SWAPNIL TRIPATHI vs. SUPREME COURT OF INDIA, W.P. (C) 1232/2017: On August 21st, 2013 a notice was issued by the Hon'ble Supreme Court of India via Registrar regarding complete ban of interns on miscellaneous days i.e. on Monday and Friday. In pursuant to this, **Mr. Aman Shekhar, Mr. Sequeira Byron, Mr. Ayush Prakash** – BA.LL.B. students of Lloyd Law College moved an Application for impleadment on July 19, 2018 in this matter seeking to revoke the complete ban imposed on interns for entering into the courtrooms on Miscellaneous days where the Hon'ble Supreme Court came to the rescue. This matter then got listed with the petition made by **Ms. Indira Jaisingh** under the same cause of action. The matter was then pleaded for **Live Streaming** of Court proceedings and the bench persuaded in petitioner's favor as they asserted that there shall be live streaming of court proceedings which will solve the grievance of interns who are not able to witness the court proceedings. The Hon'ble Supreme Court directed petitioners to assist **Ld. Attorney General for India Mr. K. K. Venugopal** for framing the guidelines for live streaming. Finally the judgment was passed and a pilot project will be followed in Chief Court of Hon'ble Supreme Court of India as soon as all the administrative compliances are duly complied with.

Gender Audit

The Gender Audit is an attempt to study whether Lloyd has good gender balance and sensitization. The college always concentrates on qualitative performance along with building the overall personality of its students. Female students are provided with various facilities to meet their needs and requirements to create a campus which is safe, adequate and sensitized towards its female students. Being a law college, it is essential that the institution offers its female and male students workshops and seminars which educate the students about laws and responsibilities. It is necessary that social, political and economic rights of women are disseminated to the students. For achieving this purpose the college has an Internal Complaints Committee, Anti-Ragging Cell, Disciplinary Committee, Cultural Committee, Sexual Harassment and Gender Cell.

Prevention of Sexual Harassment

The college has constituted an Internal Complaints Committee as per the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013. The committee conducts various programs, workshops, counseling for women empowerment and gender sensitization College is committed to provide a safe campus to female students to achieve ideals of equality enshrined in the Indian Constitution and facilitate their education and learning in the safest, secure and sound environment.

Anti-Ragging Cell and Disciplinary Committee

The college publishes regulations of the UGC and directions given by Hon'ble Courts and Legislature of U.P. in its prospectus and also the college diary which is given to all students at the beginning of every academic year. Ragging is a criminal offence and UGC has notified Regulations on curbing the menace of ragging in educational institutions in order to prohibit, prevent and eliminate the scourge of ragging. The college forms Anti-Ragging Cell and Disciplinary Committee every year.

The names and contact details of the members are notified to the students by publication of their details in the college diary which is presented to every student at the beginning of every academic year. The students in distress owing to ragging related incidents can access the committee at any times. The Anti-Ragging Cell and Disciplinary Committee comprise of both male and female members along with the HOD of the college.

Mandatory Attendance Regulation

Attending classes regularly is mandatory on each student. Attendance as taken in each class daily and is recorded and punched into the software that cannot be changed later. 75% class attendance in regular classes is the minimum criteria for appearing in the University Examination failing which the College will not approve the examination form of the students to the university. No grounds shall be considered to deflate the rule of 75% attendance. The same is in compliance with the attendance rules and criterions of the University Grants Commission (the regulator of the Universities in India), Bar Council of India (the patron of professional legal education in India), Affiliated University i.e. Chaudhary Charan Singh University, Meerut (CCS, University) and by way of various judgments as delivered by the Hon'ble Supreme Court of India.

TRANSPORT FACILITY :

College since inception in 2003 is well connected with transport facility from different parts of Delhi / NCR. There are three college bus routes thoroughly connected with Delhi Metro stations in Delhi / NCR. Transport services provided by the college run on "No profit no loss" basis. Daily attendance will be taken in the bus and matched with Class attendance, and if the student is found to be coming in the bus but not attending classes and instead found to be loitering around, the strictest disciplinary action shall be taken against that student by the disciplinary committee. No outsiders are allowed in the bus in any case, if found so, stern action shall be initiated against such student.

Academy Web-portal (ERP)

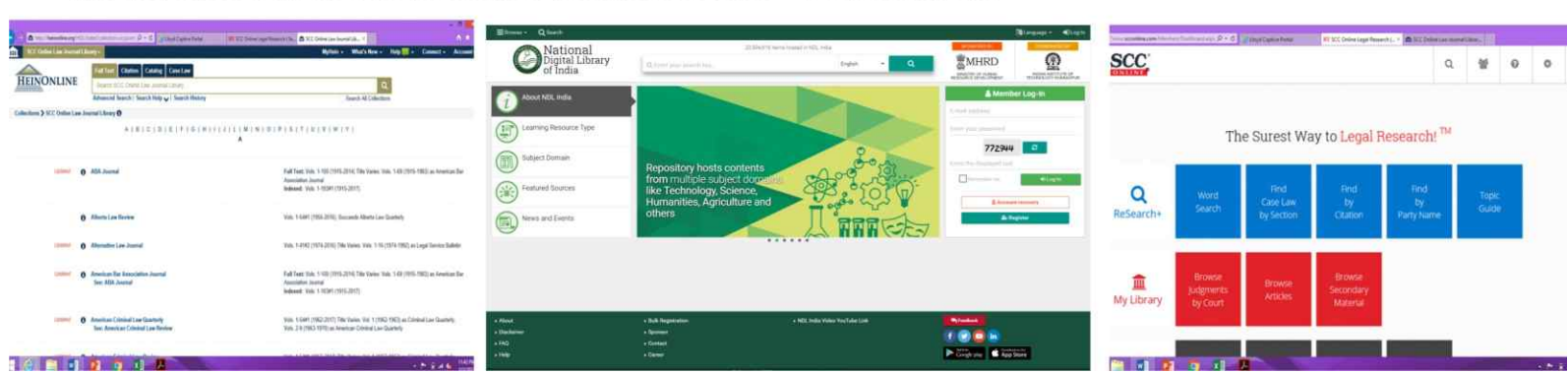

Academic Performance based Scholarship

30% Scholarship in college fee will be awarded from the second year of study for the academic excellence to top five toppers of B.A.LL.B (1, 2, 3, 4, 5 yr.) and LL.B. (1, 2, 3 yr.) in the CCS University, Meerut end term University Examinations.

Scholarships for Divyang (Differently abled)

25% Scholarship in College fee will be awarded to the students who have 40% or more disability.

Scholarship for SAARC National Students

15 meritorious SAARC Nationals will be offered a scholarship of 50% in the college fee for the normal duration of the programme based on their performance in the qualifying examination (Grade 12 or equivalent).

Online application process for LET-2019

- To register online for LET 2019, a candidate has to visit the official website of LET : <https://let.lloydlawcollege.edu.in/>
- The candidate has to then click on Create New Account and proceed to fill in her/his name, E-Mail ID and mobile number. Once the account has been created, it will take the candidate to the form filling page.

General Knowledge & Current Affairs

This section will test General knowledge & current affairs.

English including Comprehension

The English section will test the candidate's proficiency in English based on comprehension and grammar.

In the comprehension section, candidates will be questioned on their understanding of the passage and its central theme, meanings of words used therein etc.

The grammar section will include correction of incorrect grammatical sentences, fill in the blanks with appropriate words, Jumbled words & Sentences, Antonyms, Synonyms, Part of Speech, Idioms & phrases etc.

Mathematics

This section will test candidate's Knowledge of elementary mathematics up to 10th standard.

Legal Aptitude & Legal Awareness

This section will test the legal aptitude of the candidates. Questions will be framed with the help of legal propositions (described in the paper), and a set of facts to which the said proposition has to be applied.

Some propositions may not be true in the real sense (e.g. the legal proposition might be that any person

who speaks in a movie hall and disturbs other that are watching the movie will be banned from entering any movie theatre across India for one year).

Candidates will have to assume the truth of these propositions and answer the question accordingly.

Candidates will not be tested on any prior knowledge of law or legal concepts. If a technical/legal term is used in the question, that term will be explained in the question itself. For example, if the word internet crime is used, the meaning of the internet crime ("The internet crimes include that group of crimes which make criminal use of the internet infrastructure like (i) Hacking- theft of information, theft of passwords, theft of credit card number(ii) Launch of malicious programs etc") will also be explained.
