## NOTICE NO. 882 STENOGRAPHER, GRADE-III (POST CODE 21/18) IN SERVICES DEPARTMENT, GNCT OF DELHI

- 1. The DSSSB vide its Advertisement No. 02/18 with closing date 13/08/2018 and subsequent Addendum dated 07/09/2019 and corrigendum to addendum dated 10/12/2019 had advertised 256 vacancies (UR-91, OBC-101, SC-24, ST-40 including OH-05, HH-04, VH-09, Multiple Disability-01, EXSM-17 and SP-06) for the post of STENOGRAPHER, GRADE-III in Services Department, GNCT Of Delhi under Post Code 21/18. Board Conducted Tier-I written examination for recruitment in respect of this post on 04/10/2019 and 10/10/2019.
- 2. The normalized marks obtained by 11133 candidates who have duly appeared in written examination (online mode in multiple shifts) held on 04/10/2019 and 10/10/2019 have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module www.dsssbonline.nic.in
- 3. Based on the performance in Tier-I written examination (online mode), out of these 11133 candidates, total 1947 (One Thousand Nine Hundred Forty Seven) candidates (UR-728, OBC-809, SC-195, ST- 133, OH-40, VH-04, HH-01, EXSM-16 and SP-21) as detailed below, have been provisionally shortlisted to appear in Skill Test/Short Hand and Typing Test in the ratio of 1:8 subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Skill Test/Typing Test separately.

- 4. Only those candidates have been considered in OBC Category who have declared that they are OBC (Delhi) in their online application form.
- 5. The candidates having roll numbers 11250100618 belong to OBC (Outsider) thus was considered in UR Category. This candidate was overage in UR category therefore not eligible for shortlisting for Skill Test in UR Category.
- 6. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere

inclusion of names in the list of candidates qualifying for appearing in Skill Test/Typing Test does not entitled them any right over the post.

- 7. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.
- 8. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in one Tier written examinations for UR Category Candidate is 40%, for OBC Candidate is 35% for SC/ST/PH candidate is 30% and for EXSM category candidate is 5% relaxation in their respective categories subject to a minimum of 30%.
- 9. The qualified candidates for appearing in Skill Test/Short Hand and Typing Test have been called in the ratio of 1:8 of the advertised vacancies; however all the candidates who have score marks equal to the cut off marks in each category have been shortlisted.
- 10. The details of skill/Short Hand and Typing test shall be notified separately by the Board. The candidates are hereby advised to check the website of the Board regularly.
- 11. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
