

Sikkim Judicial Service Examination, 2018

EMPLOYMENT NOTICE

Applications are invited from eligible candidates for filling up 02 (two) posts of Civil Judge-cum-Judicial Magistrate (Grade- III), in the cadre of Sikkim Judicial Service, in the pay scale of Rs. 27,700-770-33,090-920-40,450-1080-44,770/- plus other allowances, as admissible under the Rules.

1. Eligibility conditions are as under:
 - (a) Candidate must be a citizen of India.
 - (b) Candidate must be a holder of a degree in law, granted by a University established by law in India.
 - (c) Candidate must not be more than 35 years of age as on the last date fixed for receipt of applications.
 - (d) Candidate must be able to communicate in Nepali, or any other language of the State.
 - (e) Candidate must have adequate knowledge Computer applications to be tested at the time of viva-voce.
2. Competitive examination shall be conducted by the High Court on the date and place to be fixed.
3. The written examination shall be conducted as per the syllabus prescribed in the Sikkim Judicial Service Rules, 1975 and same is available in the High Court's website i.e. <http://highcourtofsikkim.nic.in>.
4. All questions shall be answered in English except the vernacular paper. Answers in any language other than English shall not be considered for evaluation on any ground.
5. Viva-voce will carry 100 marks.
 - (i) Only such number of candidates shall be called for viva-voce as shall obtain the highest marks in aggregate of both the papers in the written examination, up to the extent of five times of the number of posts as specified, in the advertisement inviting applications.
 - (ii) Selection of candidates shall be made on the basis of the aggregate marks obtain in the examination and viva-voce.

6. No person who has more than one wife living and no female candidate who is married to a person, who already has a wife living, shall be eligible for appointment to the service, unless the Governor, for special reasons, exempts such person from the operation of the concerned Rule.

8. Application can be sent either by registered post or speed post but must reach the office of the Registrar General on or before 16.02.2019. Application can also be submitted in the office of the Registrar General during the office hours latest by **16.02.2019 before 2.00 p.m.** The application shall be accompanied by attested copies of the following testimonials and three recent passport size photographs:
 - (i) Certificate of Educational qualification, i.e. graduation degree and degree in law.
 - (ii) Enrollment Certificate as Advocate under the Advocates Act, 1961.
 - (iii) Proof of date of birth.
9. Incomplete application without requisite testimonials and other document shall be summarily rejected.
10. Application should be submitted in the prescribed Form which is available in the website of High Court of Sikkim i.e. <http://highcourtofsikkim.nic.in>.
11. Application received after the prescribed date and time shall not be entertained on any ground whatsoever.
12. Only those candidates found eligible on preliminary scrutiny shall be called for Written Examination. In case candidates are much more in number, preliminary examination may also be held by the High Court. The list of candidates whose applications are accepted for taking the examination shall be uploaded in the High Court website.
13. No T.A/D.A. shall be paid for appearing in the written examination and the viva-voce.

14. The Registry of the High Court of Sikkim reserves the right to accept or reject any application, with or without any reason.
15. Examination fees of Rs. 600/- shall be payable in favour of the Registrar General, High Court of Sikkim, by way of Account Payee Demand Draft of any Bank, payable at Gangtok, and shall be submitted along with the application. The said amount is non-refundable.
16. Correct mobile/ telephone number(s) for communication by the Registry should be submitted by the candidates in their applications.
