

# School of Law, Christ University (SLCU), Bangalore

## 1. Introduction

Christ University was founded and is administered by the Carmelites of Mary Immaculate (CMI). Blessed Kuriakose Elias Chavara founded the congregation in 1831. Blessed Chavara was a great educationist and a social reformer of the 19<sup>th</sup> century.

Christ University was formally established in July 1969 as Christ College under Bangalore University. The University Grants Commission conferred Autonomy to Christ College on October 7, 2004. It became the first College in South India to be reaccredited with A+ by National Assessment and Accreditation Council (NAAC) in May 2005. The UGC identified it as an Institution with Potential for Excellence. On July 22, 2008 the Ministry for Human Resources Development, Government of India, under Section 3 of the UGC Act, 1956 declared Christ College as a Deemed to be University in the name and style of Christ University.

Christ University, a premier educational institution, is an academic fraternity of individuals dedicated to the motto of excellence and service and already has a proven history of success in the field of education. The University welcomes to its fold students from all over the country in an environment of religious harmony and secularism.

## 2. The Law School

The School of Law offers Graduate, Postgraduate and Doctoral programmes in law as per the guidelines of the Bar Council of India and the University Grants Commission. The law school has a flexible curriculum offering several options in different areas of specialization. It is devised keeping in mind the requirements of legal profession and academia.

The programs offered at the law school incorporate a number of special opportunities such as internships, clinical programs, supervisory research and writing. In order to promote interaction between students and legal professionals, seminars, guest lectures and workshops are conducted at the college on various subjects of law at regular intervals. In addition to the mandatory courses over the ten semester program, the law school has also introduced for the benefit of its students numerous other value-added courses and programmes.

The School of Law has well equipped infrastructure. The entire campus is WiFi enabled. The students have access to three different library facilities, namely the general library; the specialised law library and the online library. Along with 62,000 books and 173 journals and periodicals, the general library also has a good collection of audio and videotapes for use of faculty and students. The law library has over 19,000 books and 6,000 reports. It has subscribed to 70 journals, and 13 online resources such as Manupatra, Westlaw, Hein Online, JSTOR, SCC Online, Lexis Nexis and EBSCO.

### 3. Programmes:

#### 3.1 Undergraduate Programmes

School of Law, Christ University offers five-year integrated law programs, the successful completion of which will earn the student a **BA LLB (Honours)** or **BBA LLB (Honours)** degree to be awarded by Christ University.

In addition to the mandatory courses over the ten semester program, the school has introduced for the benefit of its students numerous other value-added courses and programs aimed at putting the student on par with standard of legal education imparted at the best international universities. In this School of law, knowledge of law is imparted, by a teaching- learning process; teaching is supplemented by a variety of skills, such as skills in advocacy, legal writing, research, management of time. The courses are specifically designed keeping in mind the latest development in the field of law. The course is oriented towards the industry and is aided by an advisory board comprised of some of the leading lights in the legal fraternity.

Special emphasis on ethics, life skills and holistic education will empower the students to achieve integrity and look forward to effective contribution to the society.

##### **(i) BA LLB**

The main objective of this course is to provide in-depth knowledge in professional law courses with the four types of skills mentioned above. Since, rule of law is the cornerstone of the constitutional governance these courses of study would also focus on the public policy, both of the Central Government and the State Governments out of which flows the specific laws.

##### **(ii) BBA LLB**

The main objective of this course is to provide primarily in-depth knowledge in professional law courses with the four types of skills mentioned above. The course also focus to provide an integrated understanding of law in a environment of Financial Management, Business Administration, other managerial skills to cope the students with skills that are necessary to manage business in a fast evolving global environment emerging market so that they may develop a competitive edge while pursuing their career.
